Summary of Resources Available to January Term Faculty		
Housing	Abu Dhabi : NYUAD will provide a furnished one-bedroom apartment on campus. Campus housing is available January 2-24. Additional nights are at the faculty member's expense. Other GNU sites : NYUAD will provide furnished housing for the individual faculty member near the teaching location for January 2-25. Additional nights are at the faculty member's expense. Faculty interested in AirBNB should email links for one-bedroom apartments to Leigh Watts for approval.	
Relocation Travel	NYUAD will provide the faculty member with a cash travel allowance (faculty are responsible for all taxes associated with the allowance). The travel allowance provides flexibility, enables the faculty member to arrange his/her own travel, and varies according to the destination. The cash allowance (less taxes) is as follows:

Visas	NYUAD will fund and assist with visas, if required, for the individual faculty member only. Leigh Watts (leigh.watts@nyu.edu) initiates this process in November and will assist with any visa questions. Faculty should confirm their passport is valid for at least 6 months and has extra pages. NYUAD does not reimburse for fees associated with passport renewals, rush fees, and visas for family members.	
Miscellaneous Allowances	NYUAD will provide an allowance of \$1,200 (less taxes) to cover meals, vaccinations, laundry, ground travel, and shipment of personal books or other instructional materials during January Term (receipts are not required). NYUAD does not reimburse for meals, laundry or other miscellaneous living expenses (including meals with other faculty) incurred during the assignment.	
Information about payments	Faculty are paid via NYUNY, NYUAD, or NYUSH payrolls as employees. All payments and allowances are subject to taxes (if applicable). If you have questions about tax obligations, please contact your tax advisor. NYU faculty choosing the travel allowance must advise NYUAD before November 1. Payments will be processed according to the following schedule: Teaching payment: February 5. Travel allowance If faculty requests payment before November 1, payment is delivered December 5. If faculty requests payment after November 1, payment is delivered February 5. Miscellaneous allowance: December 5.
